

# COPAN LAKE TRAIL REGULATIONS:

Off-road vehicles are NOT permitted at any point on the trail and must remain on designated roadways at all times. This includes ATVs, UTVs, motor bikes, etc.

Camping is permitted only in designated campgrounds (Washington Cove, Post Oak, and Osage Plains).

Trash and litter MUST NOT be left on the trail and should be deposited into one of the provided containers.

Ground fires are allowed ONLY in fire rings at designated campsites.

# <u>Chapter III, Title 36, C.F.R. is enforced on this trail. VIOLATORS WILL BE CITED.</u>

Copies are available from Park Rangers and the Project Office next to the dam.

## **ADOPT A TRAIL PROGRAM:**

This program allows you or an organization to adopt a section of the trail for trail maintenance, trash-clean up, or upgrading facilities.

#### **FOR YOUR SAFETY:**

Areas shaded RED around Washington Cove, Copan Point and Project Office are designated NON-HUNTABLE AREAS.

In areas open to public hunting along the trail, Archery and Shotgun with Pellets ONLY are permitted.

Trail will be CLOSED during a special draw hunt for disabled sportsman every winter. Please contact the lake office for current dates.

During flood events, the section of the trail highlighted in BLUE may be submerged and impassible.

#### **WILDLIFE MANAGEMENT**

Copan Lake is a US Army Corps of Engineers managed lake located in northeast Oklahoma with 15,685 acres of land and water available for public use.

During your time spent on the trail, you may see a variety of wildlife, such as white-tailed deer, bobwhite quail, squirrels, rabbits, and raccoons.

Various methods of land management are used to improve the food and cover available for wildlife. Grazing leases are used to meet resource management objectives such as habitat improvement and prescribed burning is used to maintain the condition of native grassland habitat for upland game birds and other species. Other management techniques include reforestation, cover establishment, and food plots.

#### FOR THE VISITOR

## Horse trailer parking:

- From HWY 75, go west on State HWY 10 approximately 1.33 miles to the main trailhead.
- From State HWY 10, travel 1.56 miles north on N3970 road to the end of the trail, just north of the Washington Cove Campground entrance.

Hunting and fishing are regulated by Federal and State Laws, and similar licenses are required in other areas of Oklahoma.

Do not damage or remove trees or plants. Protect the forest— extinguish all fires. Keep the area beautiful for other visitors. Use trash cans to dispose of refuse.

Inquiries regarding Copan Lake and its use are welcomed by the Project Manager and copies of regulations governing public use of this lake and other information may be obtained at the Project Office near the dam.
